## SECTION I: PROJECT INFORMATION

#### **1.1 BACKGROUND**

#### Project Background

Hyderabad, the "Bulk Drug Capital of India", accounts for more than 35% of India's pharmaceutical production and around 40% of total Indian API production and approx. 50% of API exports. Telangana is home to over 800 pharma and biotech companies with a valuation of over US\$ 50 billion and Telangana is the only state in the world to have 200+ USFDA (United States Food and Drug Administration) approved facilities. Government of Telangana continues to recognize life sciences as its priority sector. World-class infrastructure, progressive policies, cluster-based approach and availability of talent creates an enviable and unique identity for Hyderabad, which continues to attract major global and Indian Lifesciences' companies to the State.

With a view to create a self-sufficient eco-system for pharmaceutical manufacturing, to reduce the import dependency of essential drugs, to provide plug and play facilities to the pharmaceutical industry and to create the alternate ecosystem with sustainable environmental systems in Hyderabad to make city free from pollution and environmental strain, Government of Telangana State intends to develop a Hyderabad Pharma City spread over an area of 19,333 acres, located in Kandukur and Yacharam Mandals of Ranga Reddy district. TSIIC initially intends to develop Zone-3 area spread over an area of Approx. 4,000 acres falling within Phase-1 of HPC.

Telangana State Industrial Infrastructure Corporation Limited (TSIIC), a wholly owned undertaking of Government of Telangana State (GoTS), is a premier organization of the State Government responsible entrusted with the objective of providing industrial infrastructure through development of industrial areas. TSIIC is the Nodal Agency to develop "Hyderabad Pharma City" (HPC) in a phased manner as the world's largest integrated manufacturing cluster for pharmaceutical industries with thrust on R&D and manufacturing.

TSIIC initially intends to develop Zone-3 area of HPC under Phase-1 development plan which is spread over an area of Approx. 4,000 acres based on approved Master Plan.

HPC is planned to have the following state-of-art infrastructure:

- a) Primary external infrastructure linkages to the site in terms of road, water, power etc.
- b) Pharma Manufacturing Zones with well-developed plots and standard factory units with all utility linkages such as steam, chilled water, fresh water, recycled water, waste- water conveyance and power supply
- c) Integrated Environment Management Infrastructure including ZLD (Zero Liquid

Discharge) based Common Effluent Treatment Plant, Sewage Conveyance System and Sewage Treatment Plant, Solid Waste Management Facility Green Belts and Green Buffers for Odour Management & Pollution Control, Rainwater Harvesting and Ground Water Recharge Systems.

- d) Technical infrastructure such as Environmental Management Cells, Quality Certification Labs, Material Testing Labs, Skill Development Centers
- e) Logistic park/s with warehousing facilities
- f) Pharma University with Research & Development Hub
- g) Township including residential, commercial, hotels etc.

Hyderabad Pharma City offers significant cost and set-up time optimization for the pharma industry with its centralized smart infrastructure solutions. HPC will provide a jumpstart platform to Life Sciences companies and help companies move-up the value chain.

Provision of steam and power supply are the essential components/Common Infrastructure Facilities of HPC and hence District Heating System (DHS) is designed for providing both to the tenants and it is proposed to be developed preferably through private sector participation on Public Private Partnership (PPP) format or any other modes including EPC (Engineering, Procurement & Construction). The mode of implementation will be decided in due course.

#### **1.2 PROJECT**


- 1.2.1 The Authority intends to develop a District Heating System (DHS) for Zone-3 area of Approximately 4,000 Acres in Hyderabad Pharma City, Telangana in a phased and modular manner.
- 1.2.2 The proposed DHS facility is to be designed to cater to the bulk demand for process steam (~1650 TPH (Tonnes Per Hour) ultimate capacity for Zone -3) for pharma industries within Zone-3 of HPC. The steam capacity is around 200 TPH per module and shall be increased on modular basis as per the requirement. Further, estimated power requirement for the entire Pharma City is 778 MVA at 220 kV level and the ultimate steam demand is 3,155 TPH. For Zone-3 area, the estimated power demand is about 200 MVA and the steam demand is 1650 TPH. To increase the efficiency of individual steam and power system, it is proposed that a Combined Heat and Power GTG+HRSG (Gas Turbine Heat Recovery Steam Generator) based cogeneration solution is proposed for Zone-3 area. This proposed system shall use Natural Gas as fuel as per the recommendations of Environmental Clearance by MoEF&CC, GoI and cater to the power and steam demands of Zone-3 area of Hyderabad Pharma city:
- 1.2.3 The Authority intends to develop DHS (the "**Project**"), preferably on PPP format having the following broad components:

- RSG steam output rating: 600 TPH (3 x 200 TPH)
- Primary GTG Fuel: Natural Gas
- Associated co-generation facility: 210 MW (3 x 70 MW)
- Supplementary firing for HRSG: Supplementary firing for additional steam generation is acceptable (subject to OEM confirmation)
- The proposed development shall be developed in a module of 200 TPH / 70 MW as per actual requirement of the system.
- 1.2.4 This proposed project is expected to enhance energy efficiency due to better technology and reduced heat losses, economies of scale, reduction in emissions across all sectors to meet national level climate change targets and also help the tenant industries to comply with their carbon goals. The overall prices for the heat (steam) are reduced due to combining it with 50% electrical energy and 40% heat energy, thereby reducing cost of operations by the tenant industries and positioning HPC as the preferred location for global industries. The proposed DHS system would produce desired amount of steam and electricity at the same time through this co-generation plant.

#### **1.3 PROJECT LOCATION & CONNECTIVITY**

#### Location:

The project site is located in Kandukur and Yacharam Mandals of Ranga Reddy district at a distance of approximately 25 km from Hyderabad Outer Ring Road (ORR) and  $\sim$  35 km from Rajiv Gandhi International Airport (RGIA). Location of project site depicted in the map shown below.





#### Connectivity:

Hyderabad Pharma City is well connected with rest of the Country by road, rail and air as mentioned below:

- <u>Road connectivity</u>: The project site can be accessed from Hyderabad via Srisailam highway (NH-765) as well as Nagarjunasagar highway (SH-19) and falls along the Kandukur-Yacharam Road. The NH 765 (Srisailam Highway) connects site on its west side, SH 19 (Nagarjuna Sagar Road) on eastern side. Site is around 25 km from Hyderabad Outer Ring Road.
- **<u>Air Connectivity</u>**: Nearest airport to the project site is Rajiv Gandhi International Airport located at a distance of ~35 km. The airport operates domestic and international flights to the various destinations of the country and rest of the world.
- <u>Rail Connectivity</u>: South Central Railway's broad-gauge trunk line passes at a distance of ~35 km. The nearest railway station is Shadnagar Railway Station on Hyderabad – Bangalore Section.

The total site area is 19,333 acres. Of this 8,900 acres is earmarked for Phase 1 development. The Zone-3 area of Approx. 4,000 acres is part of Phase-1 development.



#### **1.4 PROJECT STATUS**

• HPC is recognised as a **"Project of National Significance"** by DPIIT, Ministry of Commerce & Industry, GoI in the context of making India self-sufficient in healthcare

and reducing India's dependence on pharmaceutical imports – Accorded the Status of National Investment and Manufacturing Zone (NIMZ) by the Department for Promotion of Industry and Internal Trade (DPIIT), Ministry of Commerce and Industry, Government of India (GoI).

- Land acquisition for the first phase of HPC is nearing completion, while the balance is under process.
- HPC is positioned as a priority node / IMC (Integrated Manufacturing Cluster) in the proposed Hyderabad-Warangal Industrial Corridor (HWIC) by National Industrial Corridor Development Corporation (NICDC) Limited & National Industrial Corridor Development and Implementation Trust (NICDIT), GoI.
- Ministry of Environment, Forests & Climate Change (MoEF&CC), GoI, granted the Environmental Clearance (EC) for the entire Hyderabad Pharma City in June, 2018. Subsequently, the project has also obtained Consent for Establishment (CFE) from Telangana State Pollution Control Board (TSPCB) on 27.01.2020.

## SECTION II: INSTRUCTION TO APPLICANTS

#### 2.1 GENERAL INSTRUCTIONS

- 2.1.1 Telangana State Industrial Infrastructure Corporation Limited (the "Authority") is engaged in developing and providing industrial infrastructure in Telangana. As part of this endeavor, the Authority has decided to develop a District Heating System with a capacity of (600 TPH 3 x 200 TPH), associated Gas Turbine Generator (Cogeneration) with 210 MW capacity (3 x 70 MW) and all other associated components such as network of pipes for steam and condensate within Zone 3 area within Hyderabad Pharma City, Telangana, India (the "Project") through private sector participation preferably on DBFOT mode or or any other modes including EPC (Engineering, Procurement & Construction) and has decided to carry out the bidding process for selection of the bidder to whom the project may be awarded. The current document is Global Expression of Interest for shortlisting of the potential bidders for Request for Proposal (RFP) stage for selection of agency for implementation of the project i.e., DHS.
- 2.1.2 The Authority invites Global Expression of Interest (EOI)s for pre-qualification of interested parties (the "**Applicants**") who fulfill the eligibility criteria detailed in sections 3.1 and interested in participating for the Project.
- 2.1.3 This EOI is issued for short listing of Applicants for develop District Heating System within Hyderabad Pharma City, Telangana, India on PPP format or any other modes including EPC.
- 2.1.4 The developer selected through bid process is required to undertake Planning, detailed Engineering & Designing, Financing, Construction, Marketing and Operation & Maintenance (O&M) of proposed project as per the market requirement in consultation with the Authority. The information about the Project is detailed in Section-I.
- 2.1.5 This Expression of Interest document contains information about the Project prequalification requirements and process in relation to pre-qualification of the Applicants for further participation in the bidding process for the Project as per following sections:
  - Section I: Project Information
  - Section II: Instruction to Applicants
  - Section III: Pre-qualification Criterion
  - Annexures of formats
    - 1. Checklist for Submission of EOI
    - 2. Financial Information of the Applicant

- 3. Format for MoA (in case of Consortium)
- 2.1.6 All EoI submissions would be evaluated in terms of financial and technical capability of the Applicants, Individual or Consortium, as the case may be. Detailed information on pre-qualification criterion is provided in Section III in this EOI.
- 2.1.7 Applicants are required to read carefully the contents of this document and to provide required information, as per the checklist so that capabilities of the Applicants can be fully appreciated and evaluated.
- 2.1.8 Any amendment/addendum/corrigendum to this Expression of Interest document can be downloaded from <u>www.tsiic.telangana.gov.in</u>.
- 2.1.9 All EOI submissions would be evaluated in terms of financial and technical capability of the Applicants, Sole Firm or Consortium, as the case may be. Detailed information on pre-qualification Criterion is provided in Section III of this EOI document. Screening of EOIs shall be carried out as per eligibility conditions mentioned in this document and based on verification of testimonials submitted. EOI will be evaluated for short listing inter alia based on their past experience of handling similar type of project, financial strength of firm and presentation / proposal to the selection committee whose decision will be final. The Applicants may be required to make a presentation, if required, to a selection committee show-casing their proposals.
- 2.1.10 Pre-qualified Bidders/Consortium will be informed by the Authority through registered post/fax/e-mail.
- 2.1.11 Request for Proposal (RFP) shall be invited from amongst the pre-qualified Bidders/Consortium only and at the sole discretion of the Authority.
- 2.1.12 The Authority reserves the right to
  - a. Reject or accept the EOI,
  - b. Cancel the process and reject all or any of the EOI without assigning any reasons whatsoever.
- 2.1.13 The selection process shall be governed by, and construed in accordance with, the laws of India and the courts at Hyderabad shall have exclusive jurisdiction over all disputes arising under, pursuant to and/or in connection with the Selection Process.

#### 2.2 ELIGIBLE APPLICANTS

- 2.2.1 The Applicant for pre-qualification may be a single entity or a group of entities (the "**Consortium**"), coming together to implement the Project. However, no applicant applying individually or as a member of a Consortium, as the case may be, can be member of another Applicant Consortium. The term Applicant used herein would apply to both a single entity and a Consortium.
- 2.2.2 An Applicant shall not have a conflict of interest (the "**Conflict of Interest**") that affects the Bidding Process. Any Applicant found to have a Conflict of Interest shall

be disqualified. An Applicant shall be deemed to have a Conflict of Interest that affects the Bidding Process, if a constituent of such Applicant is also a constituent of another Applicant;

- 2.2.3 Where the Applicant is a single entity, it may be required to incorporate a company under the Companies Act, 1956 as a Special Purpose Vehicle (SPV) to execute the Concession Agreement and implement the Project. In case the Applicant is a Consortium, it should comply with the following additional requirements:
  - (a) Number of members in a consortium should be limited to 3 (three) members;
  - (b) the Application should contain the information required for each member of the Consortium;
  - (c) members of the Consortium shall nominate one member as the lead member (the "**Lead Member**"), who shall have an equity share of at least 51% in the Consortium.
  - (d) members of the Consortium shall enter into formal understanding vide a Memorandum of Association (MoA) in the format set out in Format F3, for the purpose of making the Application for the project. A consortium shall be eligible for consideration subject to the conditions set out in this Clause 2.2.

### 2.3 CHANGE IN COMPOSITION OF THE CONSORTIUM

- 2.3.1 Change in the composition of a Consortium will not be permitted by the Authority during the Qualification Stage.
- 2.3.2 Where the Applicant is a Consortium, change in the composition of a Consortium may be permitted by the Authority during the Bid Stage, only where:
  - (a) the Lead Member continues to be the Lead Member of the Consortium;
  - (b) the substitute is at least equal, in terms of Technical Capacity and Financial Capacity, to the Consortium Member who is sought to be substituted and the modified Consortium shall continue to meet the prequalification and shortlisting criteria for Applicants; and
  - (c) the new Member(s) expressly adopt(s) the Application already made on behalf of the Consortium as if it were a party to it originally and is not an Applicant/Member/Associate of any other Consortium bidding for this Project.
- 2.3.3 Approval for change in the composition of a Consortium shall be at the sole discretion of the Authority and must be approved by the Authority in writing.
- 2.3.4 The modified/ reconstituted Consortium shall be required to submit a revised Consortium Agreement before the Application Due Date.

#### 2.4 SUBMISSION OF EOI

- 2.4.1 Applicants fulfilling the prescribed eligibility criteria may submit the proposal to in a sealed single envelope having a title of envelope as: " Development Of District Heating System (DHS) For Zone-3 Area Within Hyderabad Pharma City, Telangana, India" containing following information:-

  - (iv) Audited Annual Accounts for the last three financial years (FY 2021-22, FY 2020-21 and FY 2019-20)
  - (v) Experience certificates for Development / Construction/ O&M in as per FORMAT F3
  - (vi) In case of Consortium, Memorandum of Association (MoA) as per FORMAT F4
  - (vii) Demand Draft of INR 11,800/ (Indian Rupees Eleven Thousand Eight Hundred only) (including GST @ 18%) in favour of "TSIIC Limited" payable at Hyderabad towards non-refundable processing fees
  - (viii) EOI shall be submitted at the following address by post or courier or in person latest by 16.00 IST on or before the Application Due Date i.e. 31.10.2022. The offer for EOI as per this document shall be valid for a period of four (4) months initially which may be extended further if required by the Authority.

- 2.4.2 Applicants shall submit the EOI on the prescribed format in English language.
- 2.4.3 The EOI shall be submitted along with a covering letter together with the desired supporting documents and proofs on the letterhead of the Applicant/Consortium together with each page of the document duly signed by the head or authorized signatory of the Applicant/Consortium under a common seal.

#### 2.5 APPLICATION DUE DATE

- 2.5.1 Applications should be submitted on or before 16.00 hours IST on the Application Due Date at the address provided in Clause 2.4.1 in the manner and form as detailed in this EOI. (If due to any unforeseen reason, any holiday is declared on any of the due dates, then the due date will be the next working day). The Proposals will be opened on the same day at 16.30 hours IST, in the presence of Applicants , who may wish to be present.
- 2.5.2 The Authority may, in its sole discretion, extend the Application Due Date by issuing an Addendum in accordance with Clause 2.6 uniformly for all Applicants.

#### 2.6 AMENDMENT OF EOI

- 2.6.1 At any time prior to the Application Due Date, the Authority may, for any reason, whether at its own initiative or in response to clarifications requested by an Applicant, modify the EOI by the issuance of Addendum/ Amendment which will be posted on the Official Website of the Authority (www.tsiic.telangana.gov.in).
- 2.6.2 All such amendments to RFP be posted on the Official Website of the Authority will be binding on all Applicants.
- 2.6.3 In order to afford the Applicants a reasonable time for taking an amendment into account, or for any other reason, the Authority may, in its sole discretion, extend the Application Due Date.

#### 2.7 TESTS OF RESPONSIVENESS

- 2.7.1 Prior to evaluation of Applications, the Authority shall determine whether each Application is responsive to the requirements of the EOI. An Application shall be considered responsive only if:
  - (a) it is received as per the checklist at Format-F1.
  - (b) it is received by the Application Due Date;
  - (c) it is signed and sealed;
  - (d) it contains all the information (complete in all respects) as requested in this EOI;
  - (e) it is accompanied by the Memorandum of Association (MoA) (for Consortium), specific to the Project;
  - (h) it does not contain any condition or qualification; and
  - (i) it is not non-responsive in terms hereof.
- 2.7.2 The Authority reserves the right to reject any Application which is non-responsive

and no request for alteration, modification, substitution or withdrawal shall be entertained by the Authority in respect of such Application.

#### 2.8 DISQUALIFICATION OF APPLICANT

- 2.8.1 An Applicant can be disqualified if the Applicant:
  - a. Does not meet the Eligibility Criteria of the Project
  - b. Does not submit the Application as per checklist provided in FORMAT F1 of this EOI
  - c. Makes misleading or false representations in the forms, statements and attachments submitted in the Application
  - d. Has record of poor performance such as abandoning the works, not properly completing the contract, litigation history, or financial failures, etc.
  - e. Application submitted is not accompanied with the requisite documentation or is non-responsive

#### 2.9 PROCESSING FEE
